Minutes of St. Paul's Evangelical Lutheran Church Congregational Council Meeting of January 19, 2023

Council Members Present: Christian Flathman, Andy Foose, Toni Hadden, Chuck McCallar, Lisa Neville, Drew Schwalbe, Pat Sparks, Mickie Waldhauer, and Bill Wiggins. Also present: Donald Martin and Pastor Hartmann.

Andy Foose opened the meeting at 6:00. Toni Hadden gave the Devotion. Andy Foose reported that Executive Committee had suggested for the year

Andy Foose reported that Executive Committee had suggested for the year 2023 that he serve as Vice President, Bill Wiggins serve as President, and Lisa Neville serve as Secretary. With no nominations from Council, Council members elected the suggested slate for 2023. Donald Martin will remain as Treasurer.

Bill Wiggins assumed presiding over meeting as President.

October meeting Minutes were approved via email and submitted for Epistle publication.

Pastor's Report: Report attached. Highlights include visitations in

homes, hospitals and nursing homes, normal counseling. Conducted funerals for Clarke Jones, Ralph Ranson, Terry Courson, Betty Bacon, Stan Woo and Lynette Flathmann. Christmas Play went very well. Bible Study will resume during Lent with daytime Lenten Services at 11:15 am. Help will be needed for St. Patrick's Day parking. Progressive Dinner will resume. Spring Play will be "Batman: The Musical".

Director of Music: Donald reported Choir is gearing up for Ash Wednesday, Palm Sunday, Maundy Thursday, Good Friday and Easter Sunday. Hopes to have Easter Brunch return this year.

checking at Bank of America, \$15,655.84 at Truist Bank, and Endowment accounts at present are \$1,269,969.69. Total received from Christmas Angels amounted to \$60,500. Christmas Angel opportunity began about 10 years ago for the purpose of providing seed money for the new year after closing out the books for the year.

Preschool's accounts closed December with a balance of \$20,563.99 in

Treasurer: Donald reported: To date bank balance of \$57,016.23 in

checking and savings \$80,200.70 (prior to playground refurbishment). To date 68 students are enrolled with anticipation of 70 by end of the month.

Preschool: Donald reported that staff is stable with usual movement. The Christmas program went well. Christian Flathman volunteered to provide

marketing for the school.

Property: Toni Hadden reported that Richard Wolf is still trying to reach City regarding the curb repair. Donald reported that the initial roofing/steeple repairs and complete. However, it was discovered via drone camera footage provided by Ricky Truluck that we now have some cracked slates on steeple roof and rotten facia boards. Facia boards will be repaired but Donald suggested

the HVAC, roof, 2nd floor parish building, and stained glass.

Old Business: Toni Hadden reported her findings on the costs to update the AED equipment. Donald approved Toni ordering the equipment.

New Business: Donald reported that the Savannah LGBTQ has made two requests of our parking lot. The <u>first request</u> is to use the church parking lot on

leaving slates "as is" as they are still in place just cracked. Repairs are complete for

the first Friday of every month for overflow parking for music festivals that are part of the Starland Yard music each month. After discussion Council agreed that they may use our lot for overflow parking but will be notified when our lot is not available on occasions as Good Friday, Play night, or if gym is rented on a particular Friday night that falls on the first Friday. A Certificate of Insurance will also be required as a condition for this approval. An official contract will be drawn

also be required as a condition for this approval. An official contract will be drawn up by Rebecca McClain and approved from church attorney, Rick Gnann. The **second request** is to use the parking lot for entire day one Saturday in June or July for a festival with bands and food trucks, etc. After discussion Council voted to deny this request as if a funeral occurs on the date the Savannah LGBTQ choses to have the festival, the funeral will take precedence. A Letter of Denial will be issued stating that due to control of a life, health, or safety event we cannot grant

this request.

Bill stated that he would like to start a fellowship meeting on the third Wednesday of each month with a meal. This will hopefully encourage committees to form/meet on this day, have families come to church for a meal, and provide a meal for Choir. Also, hopefully, this will provide an opportunity to request attendees to volunteer for committees or events as well as grow the "volunteer" force within the church. The first "Third Wednesday Dinner" will be February 15th.
